Inspect, clean or replace air filters once a month or as needed to reduce energy costs and prevent potential damage to your system. Make sure radiators, baseboard heaters and warm-air registers aren't blocked so air can flow freely.

Are portable space heaters efficient for your home?



Small space heaters are meant to do exactly as their name says: heat a small space. But unfortunately, many people use portable space heaters to heat their entire home, which can really take

a toll on your energy bills. The truth is, whether you should use space heaters really depends on your home's efficiency and energy needs.

If you're using a space heater to compensate for problems in your home, like inadequate insulation, drafty windows and exterior doors, or an inefficient heating system, space heaters are not a practical solution. Your best bet is to improve the overall efficiency of your home. If you're on a tight budget, caulking and weather stripping around windows and exterior doors is a low-cost, easy way to save energy. Depending on the size of your home, adding insulation can be a great next step. Loose fill insulation typically costs \$1 to \$1.50 per square foot. Taking these proactive energy-saving measures rather than relying on space heaters for supplemental warmth can reduce your heating and cooling bills for years to come.

Perhaps your home is energy efficient but you're cold-natured and want a specific room to be cozier than the rest. In this case, a space heater may work for your needs. A good comparison is ceiling fans; we use ceiling fans in the summer to cool people, not rooms. A space heater can be used in a similar way during winter months. Only use a space heater in small spaces that you're occupying and, if possible, try to shut off other rooms to contain the warmth provided by the space heater. If you decide to use a space heater to heat a small area in your home, make sure the heater is properly sized for the space; most heaters include a general sizing table.

A word about safety: the U.S. Consumer Product Safety Commission estimates

more than 25,000 residential fires are associated with the use of space heaters every year, resulting in more than 300 deaths. If you must use a space heater, purchase a newer model that includes the most current safety features and make sure it carries the Underwriter's Laboratory (UL) label. Choose a thermostatically controlled heater to avoid energy waste and overheating, and place the heater on a level surface away from foot traffic when in use. Always keep children and pets away from space heaters.

Consider alternative ways to stay warm like extra layers of clothing or UL-approved electric blankets. If you have hardwood or tile floors, lay down area rugs to provide additional insulation (and appeal!) and maintain warmth.

We know it's cold out there, but remember in addition to safety concerns, space heaters can greatly increase your energy bills if used improperly.

ANNUAL MEETING & DIRECTOR NOMINATION PROCESS

Mark your calendar for Monday, April 4, for the Daviess-Martin County REMC Annual Meeting! Plans are being made to hold the meeting at the North Daviess High School gymnasium. Registration will run from 5:30 p.m. until the start of the 7 p.m. business meeting. Meeting arrangements may need to be altered depending on the status of Covid. Any necessary changes will be announced as soon as possible.

Business meeting action items will include:

- The election of two directors for the cooperative to serve terms of three years. Districts up for election include District 1 (Elmore, Madison, Steele and Bogard townships in Daviess County) and District 4 (Harrison and Reeve townships in Daviess County).
- Approval of reports for the previous fiscal year.
- Transacting such other business as may come before the meeting.

Incumbent directors whose terms expire but also plan to seek a seat on the board of directors include:

- District 1: Joshua Dove
- District 4: Terry Chapman

In accordance with DMREMC bylaws, nominations for members to become a director on the REMC board shall be made by petition. Valid nominating petitions must be submitted to the REMC no later than Feb. 18. Interested parties should contact the REMC office during normal business

hours Monday through Friday, 7:30 a.m. – 4 p.m., for petition details and to request an informational packet.

In lieu of a petition, incumbent board members may file a written notice at the office of the cooperative not less than 45 days before the annual meeting of the members of the cooperative stating his or her intention to seek a seat on the board of directors.

The 2022 director election will be administered through Survey Ballot Systems (SBS). Every REMC member will receive a voting packet through

the mail from SBS. REMC members can complete the ballot, and mail it to SBS. This may need to be tweaked with added dates of when these packets are mailed and when they need to be returned. Or, REMC members can vote electronically. Instructions on voting options will be provided in the voting packet by SBS. SBS has security in place to prevent more than one vote per member.

The official notice of the annual meeting will be provided in the mailing from Survey Ballot Systems along with director candidate information.

RESAP is administered by the National Rural Electric Cooperative Association. It is a peer-review safety and loss control evaluation of electric utilities. About the Program

Your electric cooperative is offering a 2022 residential rebate for qualifying equipment (water heaters, geothermal heat pumps and air source, ductless mini-split or dual fuel heat pumps). To qualify, you must occupy the home where the equipment is installed year-round (12 months) and unit must heat and cool the whole home, unless otherwise stated.

Please provide the following documents to your electric cooperative to apply for possible rebates*:

- AHRI (Air conditioning, Heating and Refrigeration Institute) certificate for validation of all SEER ratings. (This can be obtained from the installing heating and cooling contractor.)
- 2022 Residential Rebate Application
- Proof of purchase (invoice or receipt)



Water Heater (Heat Pump or Hybrid)

New construction or replacing gas or electric



Geothermal Heat Pump

New construction or replacing electric resistance heat, gas, heat pump or geothermal



Air Source or Dual Fuel Heat Pumps

Heat pump replacing gas, existing A/C or heat pump, new construction or replacing 100% electric resistance heat



Mini-Split Heat Pump

Single room or whole home installations



HVAC Tune-Up

Air source and geothermal heat pumps and central air conditioning systems

Must apply by Dec. 15, 2022
