# Tree trimming improves service for all



One of the things I love best about our community is the natural beauty that surrounds us. We are fortunate to have many trees that offer beauty,

shade and a habitat for all sorts of birds and other wildlife. We know that you appreciate our community for many of the same reasons.

At Daviess-Martin County REMC, we strive to balance maintaining beautiful surroundings and ensuring a reliable power supply by keeping power lines clear in rights-of-way (ROW).

While we recognize and appreciate the beauty of trees, there are three main benefits to tree trimming in ROW areas. A right-of-way is the land we use to construct, maintain, replace or repair underground and overhead power lines. Rights-of-way enable the co-op to provide clearance from trees and other obstructions that could hinder the power line installation, maintenance or operation. ROW areas are typically on public lands or located near a business or home. Regardless, Daviess-Martin County REMC must be able to maintain the power lines above and below the ROW. Proactive vegetation management benefits co-op members in three tangible ways.

#### **SAFETY**

First and foremost, we care about our members and put their safety and

that of our lineworkers above all else. Overgrown vegetation and trees pose a risk to power lines. Electricity can arc, or jump, from a power line to a nearby conductor like a tree. For information about trimming responsibilities, please refer to the infographic "Who Owns What?" on the next page.

#### RELIABILITY

Of course, one of the biggest benefits of a smart vegetation management program is reliability. Strategic tree trimming reduces the frequency of downed lines causing power outages. Proactive trimming and pruning keep lines clear to promote reliability.

#### **AFFORDABILITY**

As you know, Daviess-Martin County REMC is a not-for-profit cooperative, and that means we strive to keep our costs in check in order to keep our rates affordable. If trees grow too close to power lines, the potential for expensive repairs also increases. Effective tree trimming and other vegetation management efforts keep costs down for everyone.

Our community is a special place. We appreciate the beauty trees offer, but we also know our community depends on us to provide reliable energy. Through vegetation management, we are better able to keep the power lines clear, prepare for future weather events and secure the reliability of the grid.



# ANNUAL MEETING UPDATE

The 2021 Daviess-Martin County REMC Annual Meeting on April 8 looked much different than past annual meetings. We missed seeing our REMC members as they were not allowed to attend the meeting due to the COVID-19 pandemic. A new method for members to vote for directors was introduced which allowed either a mail-in or electronic voting option. Survey & Ballot Systems (SBS) administered the voting process.

There was a total of 1,793 voting members who each received a \$10 electric bill credit. Voting members could receive a small gift from the cooperative by presenting the top part of their ballot and visiting the REMC drive-through during regular business hours to claim the gift. In addition, there were drawings held each week during the director election from March 15 to April 2 for a number of electric bill credits. All members whose votes had been received by the time of each drawing were included in the weekly drawing.

The annual meeting — which was attended by only the board of directors, director candidates, co-op attorney and REMC staff — began at 7 p.m. at the headquarters facility. The business meeting was led by Board President August Bauer. Board Secretary Travis Summers gave the secretary's report.

A motion was made and seconded to approve the minutes of the April 11, 2019, annual meeting.

The legal report and director nomination process was given by Chris Goffinett, cooperative attorney. Goffinett reported the director seats up for re-election included Districts 2, 5 and 7. Incumbents for those Districts included Dean Harrawood, District 2 (Van Buren and Barr townships in Daviess County); Travis Summers, District 5 (Perry and Center townships in Martin County); and John Edwards, District 7 (Marion and Spice Valley townships in Lawrence County). The incumbents each timely filed a written notice at the office of the corporation stating their intention to seek a seat on the board of directors. In addition, three nominations were received by petition as follows: one for District 2 from Amy Burris; one for District 5 from Joshua Bauer; and one for District 7 from Joe Haworth. Director election results announced by Goffinett were as follows:

## REALIGNING OUR RATES TO MEET YOUR NEEDS

Daviess-Martin County REMC is dedicated to providing electric services and energysaving programs to our members in a safe, reliable and economic manner. The board of directors understands that this is a difficult time for our members. Unfortunately, we are not immune to market forces, economic uncertainty and cost increases. A recent study shows that our current customer charge does not sufficiently cover the fixed costs of providing the minimum amount of equipment necessary for a customer to access the electric grid.

As a not-for-profit electric cooperative, we structure our rates to reflect the costs of providing electric service to you - our members. The customer charge enables us to purchase and maintain our meters. poles, lines, transformers, and vegetation management. Everyone shares the costs of our facilities because the system operates as a whole and providing reliable service to everyone is what a cooperative is all about.

As of this month, the rate change will be approximately 5.5% and will be reflected on the June billing. This change will adequately and fairly recover costs through the correct components of your monthly bill including the customer charge, energy use (kWh) charge, and demand (kW) charge. This new rate design change will allow us to continue providing our members with quality, reliable and safe electric service, without harming the financial health of the cooperative.
