

Here you will also find the forms needed to claim your capital credit. If you are an heir to a past member who we still have an unclaimed capital credit for, you will also find the proper forms here.

The deadline to claim these credits is Oct. 31. After this date, the credit amount will be treated as donated cash and no longer be eligible to claim.

FEEDING THE COMMUNITIES

Daviess-Martin County REMC's lending institution, CoBank, has a program called Sharing Success. This program will match the contribution of its customers to 501c(3) charitable organizations and causes. By being an eligible customer of CoBank, Daviess-Martin County REMC may request matches for up to four contributions. Daviess-Martin County REMC selected a food bank from each of the three counties they serve. Those food banks included Feed My Sheep of Daviess County Inc., St. Vincent de Paul Society in Martin County, and Bedford Community Care Center Inc. in Lawrence County.

Daviess-Martin County REMC completed applications for the three food banks, and all were approved. DMREMC was pleased to inform the three 501c(3) food bank organizations that they will receive a total contribution of \$7,000 each.

Half of each contribution will be from CoBank's Sharing Success Program and Daviess-Martin County REMC.
