Giving back is the cooperative way

The holiday season brings a spirit of generosity and compassion. It's a time to reflect on our many blessings and uplift those in need. While this is certainly a special time of year, cooperatives like Daviess-Martin County REMC are deeply rooted in giving back to their local communities year-round.

Our mission is reliable power. Our purpose is people — the members we're proud to serve. As a Daviess-Martin County REMC member, you help us power that purpose. Daviess-Martin County REMC's Operation Roundup program is made possible through members' participation in "rounding up" electric bills to the next dollar amount. Your generous contributions help support local charitable organizations and community services.

Another way Daviess-Martin County REMC gives back is by investing in tomorrow's leaders. Through presentations at elementary schools, Camp Kilowatt, and the Electric Cooperative Youth Tour program, we aim to empower students for a brighter future. When we invest in our local youth, we strengthen the fabric of our community.

As a not-for-profit electric cooperative, we believe in giving credit where credit is due — to the members who shape our co-op. One way we do this is through capital credits. Because Daviess-Martin County REMC operates at cost, we give cash back to our members rather than outside investors or shareholders.

Here's how capital credits work Daviess-Martin County REMC members use the electricity we provide and pay their monthly bills, and we track their business with the co-op over time. Daviess-Martin County REMC pays all operating expenses throughout the year, and if any operating revenue is left over, we allocate it as capital credits. When financial conditions permit, the coop's board of directors votes to pay capital credits back to the members. Daviess-Martin County REMC sends you a check or applies a credit to your energy bill.

Since 1969, Daviess-Martin County REMC has returned \$15,168,000 to our local members.

Capital credits are just one of the many benefits of co-op membership. Giving back to our local members instead of outside parties is one of the many aspects that set cooperatives apart from other types of businesses.

Our members guide every decision we make and are why our co-op exists. To us, you're more than a customer. This holiday season, we hope you're proud to be part of a community-focused co-op that puts people before profits.

What are capital credits?

One of the benefits of being a DMREMC member is patronage capital credits. Patronage capital credits come from margins, or money left over at the end of the year after all operating costs and expenses have been paid. These margins are allocated to each member's capital credit account based on how much electricity the member purchased that year.

Each year, the board of directors determines whether the cooperative is financially able to pay prior years' capital credits back to the members. When so approved, the cooperative refunds the designated prior year's capital credits to the members

who used electricity during the selected years.

This year's patronage capital credits are for 1996 and 1997 and will be distributed in Dec. 2024. Daviess-Martin County REMC will pay the retired amount by either mailing a check or applying a bill credit to the current member's account.

The capital credits remain on your account even if you move and are no longer a cooperative member. Please update your mailing address with Daviess-Martin County REMC for future capital credit checks.



Each year, Daviess-Martin County REMC is committed to helping fulfill our community's needs at various organizations. This year, we are asking for your help in providing supplies for our friends at the local animal shelters. Through the month of December, bring any pet supplies (food, soaps, training pads, collars, leashes, treats, etc.) you would like to donate to the Daviess-Martin County REMC office. When you drop your donation off, we will enter you for the chance at one of four \$50 bill credits. We will draw for our winners on Jan. 2.

UNCLAIMED CAPITAL CREDITS

Pursuant to the law of the State of Indiana (I.C. 8-1-13-11) and the Bylaws and Policy of Daviess-Martin County REMC, the notice of unclaimed capital credits is being made, and DMREMC is taking steps to remind current and former members of the prior distribution of capital credits. This list will be posted on the Daviess-Martin County REMC website homepage (dmremc.com) starting Dec. 13, 2024.

Active and former members must claim any cash retirement or capital credits within two (2) years after payment has been made available to such person. This year's unclaimed credits were released in 2022 and were for the years of 1993, 1994, and 1995.

Interested individuals should review the Unclaimed Capital Credits list and call the DMREMC office during regular business hours at 812-295-4200 to gather details on the amount owed to the individual. A request for retirement of capital credits can be filled out from the Claim Form link on our website.

Once claimed, members will receive a bill credit or check for unclaimed prior years' retirement amounts within the 60-day period. If said credits are not duly claimed within sixty (60) days between Dec. 13, 2024, and Feb. 13, 2025, the sum owing by the cooperative to any member shall be treated as donated cash.
